#### What constitutes an Independent Expenditure?

Per W.S. 22-25-102(k), "For purposes of this subsection, "independent expenditure" means an expenditure that is made without consultation or coordination with a candidate or an agent of a candidate whose nomination or election the expenditure supports or whose opponent's nomination or election the expenditure opposes."
